Director's Message

I am very happy to announce that the Oregon-Idaho HIDTA's Information Sharing and Analytical Coordination Center (ISACC) is fully staffed and operational! ISACC will be led and managed by Cam Strahm who recently retired as the Drug Enforcement Administration's Assistant Special Agent in Charge in Oregon. Cam brings over 30 years of Federal law enforcement and leadership expertise to his new role. Cam will be joined by Terra Duncan who has been hired as our Strategic Threat Analyst. Terra brings 17 years of HIDTA analytical experience to the position.

ISACC will enhance the effectiveness and efficiency of the program by fulfilling the deconfliction and information sharing needs of the Oregon-Idaho HIDTA enforcement and support initiatives. ISACC will operate under a "hub and spoke" model, by receiving and analyzing relevant information and then reporting it back out. ISACC will also coordinate and respond to requests for information either directly or indirectly by connecting points of contact.

The Oregon-Idaho HIDTA Program partnered with the Oregon Narcotics Enforcement Association (ONEA) to sponsor an enforcement recognition and awards program. Oregon-Idaho HIDTA and ONEA created 10 award categories (5 team and 5 individual) and solicited for nominations. All of the nominations received were evaluated by a committee. As a result of the nomination and evaluation process 7 award winners were chosen and honored during a luncheon at the Oregon-Idaho HIDTA/ONEA Training Institute on July 12, 2022.



BANNOCK AREA DRUG GROUP ENFORCEMENT SQUAD

• On April 12, 2022, Bannock County Sheriff's Office deputies served a search warrant on a home in McCammon, ID. The search warrant followed the arrest of two people after three pounds of marijuana was discovered in a vehicle during a traffic stop earlier in the week in Pocatello.

Inside the home, investigators found 18 firearms—one identified as stolen—three pounds of psilocybin mushrooms, 12 pounds of marijuana, 25 pounds of cannabis THC concentrate known as "crumble," several loose prescription pills, scales, packaging material and paraphernalia. Detectives also found more than \$57,000 in cash. Initial field tests indicated some of the THC concentrate, or "crumble," was laced with fentanyl.

The two people taken into custody following Monday's traffic stop, Treyl D. Torres and Raschel D. Thomsen were initially booked into the Bannock County Detention Center on one felony count of marijuana trafficking. They now face additional charges.

BLUE MOUNTAIN ENFORCEMENT NARCOTICS TEAM

• During the 2nd quarter of 2022, Blue Mountain Enforcement Narcotics Team (BENT) detectives have continued to investigate a mixture of cocaine, methamphetamine, and fentanyl cases, opening 28 new cases. The taskforce served 3 search warrants resulting in 18 arrests and the seizure of 6 firearms, over \$1,000 in cash, and multiple pounds of drugs.

Also during the 2nd quarter, BENT assisted Morrow County Sheriff's Office with a drug investigation resulting from a traffic stop.

Investigators subsequently seized 990 dosage units of fentanyl pills, 2.24 grams of powder fentanyl, 83.74 grams of methamphetamine and made one arrest.



CLACKAMAS COUNTY INTERAGENCY TASK FORCE

In mid-May 2022, members of Clackamas County Inter-Agency Task Force (CCITF) coordinated a buy bust after a known felon and dealer randomly reached out to a CCITF member's undercover Facebook account offering to sell 300 blues (Fentanyl M30 pills) for \$4.50/pill. A "date" was set up between the dealer and an undercover officer at a Clackamas area restaurant.

Upon arrival, the suspect was immediately taken into custody and learned his "hot date" was in fact with a member of CCITF. He was found to be in possession of two concealed firearms, ammunition, four explosive devices, over

1,200 fentanyl pills, and approximately \$1,400.

In mid-June, members of CCITF assisted Homeland Security Investigations (HSI) in a buy bust in a parking lot in Oregon City. A Confidential Informant (CI) was put in touch with a Source of Supply (SOS) in Mexico and a deal was arranged to deliver a large quantity of methamphetamine.

The CI arranged to meet the local contact in a parking lot and investigators set up in advance to take the driver down. Upon arrest, investigators found the pre-arranged deal for methamphetamine wasn't what was expected. Instead, investigators found 3 kilograms of heroin hidden behind the vehicle seats. CCITF and HSI investigators took two subjects into custody.









CENTRAL OREGON DRUG ENFORCEMENT

• On April 10, 2022, the Central Oregon Drug Enforcement Team (CODE) concluded a long-term investigation with the arrest of Dallas James Harper, age 33, of Prineville, Oregon. As a result of an anonymous tip, drug agents identified Harper as a fentanyl distributor in Crook County and the central Oregon region. The initial investigation alleges Harper was importing controlled substances from the Portland area into Crook County.

Based on the investigation and several surveillance operations, CODE detectives applied for and obtained a search warrant for the rental car Harper was driving. Later the same day, Harper and his passenger, Justine Durham, were stopped by Crook County Sheriff's deputies, and the search warrant was executed. During a search of the rental car, investigators located a commercial quantity of counterfeit pharmaceutical pills made of fentanyl, methamphetamine, and heroin. In addition to the controlled substances, a loaded pistol was also seized from Harper.

• CODE detectives concluded a long-term investigation involving illicit indoor marijuana growing operations at several locations around Crook County. The investigation alleges a Prineville couple selling black market marijuana products outside of Oregon and from "Herbology", a retail nursery supply store in Prineville, not licensed to sell, export or grow cannabis.

On May 11, 2022, CODE detectives, with the assistance of the Central Oregon Emergency Response Team (CERT), executed multiple search warrants on the home of Robert and Fawn Griffin (age 48 and age 46, both of Prineville, OR), a commercial indoor growing facility and their retail store. As a result, detectives located approximately 1,880 marijuana plants in various stages of growth, 168 lbs. of processed marijuana, over \$20,000 in US currency, three rifles, and two pistols. Detectives also discovered a complex money laundering scheme involving real estate and structured banking transactions. Both Robert and Fawn Griffin were detained by the CERT team and later arrested by detectives at the scene.

The possession of small amounts of marijuana is legal for recreational use in Oregon. However, large, unlicensed marijuana operations remain illegal. These unregulated operations pose dangers to the public and the environment. The Griffin's commercial growing operation was located in a residential area of Juniper Canyon, an unincorporated area of Crook County. Most of the residents in this area are dependent on the ground or well water for their households. In March 2022, Governor Brown declared Crook County to be in extreme drought conditions and struggling with consistent groundwater sources. Investigators have found illegal marijuana grows diverted or stole significant water from nearby homes, commercial farms, or directly from pumps connected to underground sources in the arid central Oregon high desert. This particular grow site used underground well water and maintained a complex watering system that supplied marijuana production. Additionally, illegal marijuana farms often use pesticides and insecticides that threaten residential water supplies and endanger the end user.

The Crook County Sheriff's Office, Prineville Police Department, and Oregon State Police assisted with the investigation, eradication, and dismantling of this site.

• CODE detectives concluded a long-term investigation with the arrest of Judith L Carter, age 42, of Prineville, Oregon.

Drug agents identified Judith Carter as a fentanyl and methamphetamine importer and distributor within Crook County from the Portland metropolitan area.

On May 14, 2022, after a multi-day surveillance operation throughout the Portland metropolitan area, CODE detectives, with the assistance of Oregon State Police troopers and Jefferson County Sheriff's deputies, stopped and detained Carter at a Madras truck stop. A subsequent search of Carter's Hyundai SUV located a commercial quantity of methamphetamine and counterfeit prescription pills made of fentanyl. In addition to the drugs, agents seized additional evidence supporting the investigation and have identified several associates of Ms. Carter. More arrests are expected as the investigation continues. Ms. Carter was lodged in the Jefferson County Sheriff's Jail.

• On June 1, 2022, the CODE team concluded a short-term investigation with the arrest of Johnny Stavrakis, age 39, and his wife, Martha Stavrakis, age 42, both of Gladstone, Oregon.

During a concurrent investigation, drug agents identified the husband and wife as fentanyl traffickers in the central Oregon area. The initial investigation alleges Mr. and Mrs. Stavrakis imported fentanyl pills from the

Clackamas County area into central Oregon where they distribute it. During a surveillance operation in the Redmond area, CODE detectives observed criminal behavior consistent with drug distribution. At approximately 10:35PM, the Stavrakis' were contacted during a traffic stop on Highway 97 at mile post 124. An Oregon State Police drug detection K9 immediately alerted to the presence of a controlled substance inside the Stavrakis' 2022 Honda Civic.

During the traffic stop, they provided fictitious names and became uncooperative to prevent detectives from discovering two outstanding arrest warrants for Mr. Stavrakis. During a subsequent search, CODE detectives located and seized a commercial quantity of fake pharmaceutical tablets made of fentanyl and other evidence of commercial drug sales. Mr. Stavrakis was lodged in the Deschutes County Sheriff's Jail. Mrs. Stavrakis was cited, in lieu of lodging.

• On June 14, 2022, detectives with the CODE team, Jefferson County Sheriff's Office, Deschutes County Illegal Marijuana Enforcement team, and Unites States Homeland Security Investigations concluded a two-year investigation involving an international drug organization that is alleged to be growing and processing illicit marijuana from Madras and Culver, Oregon before delivering it to Portland for nationwide distribution.

This case began with community complaints, and tips about several of the organization's twenty grow locations in the Jefferson County area. As a result, Jefferson County Sheriff's Office detectives began investigating and discovered a complex criminal network that required investigative assistance. The Jefferson County Sheriff's Office detectives requested the assistance of the CODE team and the Deschutes County Illicit Marijuana Enforcement (DCIME) team to further their investigation. Over the next 18 months, CODE and DCIME detectives, special agents, and intelligence analysts conducted hundreds of hours of physical and electronic surveillance on over twenty-three members of the organization, twenty properties, bank accounts, and Chinese food restaurants around the pacific northwest and Asia.

With the assistance of the U.S. Drug Enforcement Administration, Internal Revenue Service, U.S. Customs and Border Patrol, U.S. Department of Homeland Security, CODE, and DCIME, detectives determined the organizational structure and identified the leadership. It was discovered that proceeds from the marijuana sales were often laundered through Chinese restaurants and businesses before being diverted back to China disguised as an international business transaction.

Robert Joseph Dale, age 64, of Madras, Oregon, is alleged to be one of the leaders in this criminal organization. The illicit grow site properties are owned mainly by Robert Joseph Dale or with his family members or a business entity owned and controlled by Mr. Dale. Additionally, a few other property owners have been identified as members of the organization and are still outstanding at his time. Most of the fourteen Chinese laborers contacted by detectives were trafficked into the United States through Mexico and found work in restaurants throughout Oregon and Washington. Later, this cartel organization recruited restaurant laborers to work in the illegal marijuana trade for salary. The laborers were found living at the grow sites and often were moved by the cartel from grow site to grow site. CODE and DCIME detectives, with the assistance of the Deschutes County Sheriff's Office SWAT Team, the Central Oregon Emergency Response Team (CERT), and the Southern Oregon OSP Marijuana Team executed six search warrants at:

- 885 SW Ford Lane, Culver, OR
- 141 SW Dover Lane, Madras, OR
- 1932 SW Bear Drive, Madras, OR
- 8781 SW Feather Drive, Culver, OR
- 1735 NE Hilltop, Madras, OR
- 1703 NE Hilltop, Madras, OR

During the search warrants, fifteen people were detained, and 16,240 lbs of processed marijuana, 17,704 plants, 4 firearms, and a large US currency cache were seized as evidence. Ten laborers were detained, identified, interviewed, and later released by detectives. Five people were arrested at the scene and later lodged at the Jefferson County Sheriff's Jail. The following people have been charged with the Unlawful Manufacturing, Delivery and Possession of Marijuana. In addition to the above charges, Robert Dale was also charged with the Unlawful Possession of a Firearm. Robert Joseph Dale, age 64, of Madras, Oregon; Dong Hai Zhu, age 51, of Beaverton, Oregon; Sky Hong He Su, age 39, of Portland, Oregon; Wenjian Yan, age 36, of Brooklyn, New York; and Sam Chen, age 45, of Madras, Oregon. Several additional suspects, both foreign and domestic, have been identified.

Detectives expect additional arrests are forthcoming once additional follow-up investigations are complete.

CODE and DCIME dismantled the largest, more active grow sites operated by this organization. Investigators know the remaining locations and will dismantle those sites soon.

DOUGLAS INTERAGENCY NARCOTICS TEAM

• On April 7, 2022, detectives with the Douglas Interagency Narcotics Team (DINT) executed a search warrant on three warehouse buildings in the 300 block of Hayward Lane, in Glendale, OR. There had been ongoing suspicious activity at the location to include a high volume of workers coming and going, and materials and personnel trucked in and out during late night hours. The buildings had been modified with air filtration systems, water lines running inside the building, all the windows boarded up, and the overwhelming odor of marijuana coming from inside, among other things. Detectives attempted to contact the occupants of one building by knocking on the doors, but an unknown person locked the doors and hid inside, ignoring all attempts to communicate. Detectives surrounded the location and applied for a search warrant. Detectives obtained, and then executed the search warrant at approximately 7:00 PM. Upon entering the building, detectives found 29 year old Eduardo Hernandez-Reyes, of Medford, OR hiding inside.

Inside the buildings detectives found a substantial and sophisticated illegal marijuana growing operation. There were marijuana plants in multiple stages of growth from starter plants, all the way to mature plants ready for harvest. There was also a substantial quantity of processed marijuana ready for sale. The warehouses contained an elaborate, unpermitted, and dangerous electrical system. It has been reported there have been at least two electrical fires at this location in recent months, likely due to a poorly constructed, and overburdened electrical system. Detectives could see burn marks on the outside of one of the buildings where a previous fire had occurred. The indoor grow areas contained a huge volume of sophisticated and expensive lighting equipment, as well as watering systems and air filtration systems. Hundreds of fans, timers, monitoring equipment, etc. all of these requiring vast quantities of electricity. There was also a large volume of fertilizers and pesticides.


In total, detectives seized approximately 4,100 pounds of processed marijuana ready for sale, and 18,461 live marijuana plants in various stages of growth. This property is directly adjacent to Glendale High School, the school and kids clearly visible from the property.

• During the 2nd quarter of 2022, DINT has addressed several illegal marijuana sites in Douglas County. In total, DINT has eradicated illegal marijuana from 5 sites, and made several arrests.

DINT eradicated two sites on Raleigh Drive, outside of Winston, OR. In the 600 block of Raleigh Drive, DINT located a property that had 18 greenhouses containing illegal marijuana plants. DINT eradicated 3,832 marijuana plants from the property, and seized several other items of evidence of criminal activity. In this case, DINT arrested 25 year old Jesus Manuel Martinez-Munguia, and 42 year old Ezequiel Martinez-Garcia, both lodged at the Douglas County Jail.

In the 500 block of Raleigh Drive, DINT detectives located another illegal marijuana grow operation consisting of approximately 1,330 marijuana plants. In this case, detectives arrested the property owner, 43 year old Jackie Willis, who was lodged at the Douglas County Jail.

Detectives located another illegal marijuana growing operation in the 1600 block of Weaver Road, in Myrtle Creek, OR. In this case detectives eradicated 757 marijuana plants, and approximately 311 pounds of processed marijuana. Detectives discovered the suspects had been diverting large amounts of water from the adjacent BLM land. They discovered an area on the BLM land where a creek had been impounded to collect water, and that water was run through pipes a great distance to the marijuana growing operation. Detectives also seized a Bushmaster AR-15 rifle from the residence. A check of the serial number revealed the rifle had been reported stolen out of San Joaquin County, California. 35 year old Arturo Perez-Aguilar was arrested and lodged at the Douglas County Jail.

Detectives eradicated approximately 1,765 plants from a location in the 1200 block of N. Old Pacific Hwy in Myrtle Creek. Again, all of these plants were illegal marijuana.

At a residence in the 700 block of Buckhorn Road, Roseburg, detectives located and eradicated 1,103 illegal marijuana plants.

In many of these cases, the investigations are continuing and more arrests are anticipated. Southern Oregon has been inundated with large scale illegal marijuana grows during the last couple of years, including Douglas County. The scale of these operations is unlike anything ever seen before and they are destructive to our communities. These operations are most often run and controlled by multinational criminal organizations with only profit in mind. They pay no regard to local resources, rules, laws, or ethics. They often do vast amounts of damage to natural resources, and damage streams and rivers by dumping garbage, toxic chemicals (fertilizers, pesticides, and herbicides), and human feces. Water diversion is another concern as they often illegally take water from wells and rivers. It is common to see them illegally damming small streams to impound water for their own use. Douglas County is committed to pushing back against these illegal activities and restoring long held standards.

• On June 21, 2022, 25 year old Alejandro Guadalupe Martinez was arrested and lodged at the Douglas County Jail regarding a previous investigation by DINT detectives.

In January of this year, detectives served a search warrant at Martinez's residence in the 600 block of Gross Loop in Canyonville, OR. During the search, detectives found approximately 546 pounds of processed marijuana packaged in 1 pound bags, and stored in boxes, ready for shipment. Also found was a small number of growing marijuana plants, an undisclosed amount of cash, as well as other evidence of drug trafficking.

The residence was unoccupied at the time of the search warrant, as Martinez had been taken into custody earlier that morning by police in Fresno County, California on unrelated charges. Martinez was later released from custody in California in March after posting \$100,000 bond. Additionally, Martinez is on parole in the state of California, and a condition of his parole is that he is not allowed to leave the State of California.

On June 21st, DINT detectives learned Martinez was back in the area, and notified deputies of the information. At approximately 3:00 PM, a Douglas County Sheriff's Deputy found Martinez broke down on the side of I-5 south of Canyonville. Martinez was taken into custody without incident and lodged at the Douglas County Jail on charges of Unlawful Possession of Marijuana, Unlawful Manufacture of Marijuana, Laundering a Monetary Instrument, and Attempt to Commit Class B Felony.

HIDTA INTERDICTION TASKFORCE

• During the second quarter of 2022, members of the HIDTA Interdiction Taskforce (HIT) conducted multiple interdiction missions on all the major bus carriers in the Portland metropolitan area. All of these missions involved narcotics couriers traveling from Mexico or California into Oregon. This is a common drug trafficking route for methamphetamine, cocaine, heroin and fentanyl traveling to the Portland metropolitan area.

Investigators utilized a variety of methods including consensual encounters and a K9 while conducting these missions. Pictured below is evidence from four seizures made during these missions. Many of these seizures led to investigators passing information to California and Washington to further active cases or initiate new cases. During these targeted missions, HIT investigators seized over 43 pounds of methamphetamine, 12 pounds of cocaine, 4 pounds of fentanyl and 36,000 counterfeit M-30 pills which contain fentanyl.








• On April 27, 2022, members of HIT were working on the first level of a fentanyl overdose case. HIT members conducted a knock and talk at the 17 year old fentanyl dealer's residence and gained consent to search his room.

Inside the residence officers found 244 grams of cocaine, 2,000 blue M30's, a 9mm handgun, and \$276,722. The subject admitted the money came from the sales of drugs. The subject cooperated and assisted with the investigation which led to more arrests and seizures.







IDAHO STATE POLICE - DOMESTIC HIGHWAY ENFORCEMENT


• On April 25 - 26, 2022, the Idaho State Police (ISP) DHE team, in conjunction with Ada County Sheriff's Office, Canyon County Sheriff's Office, Elmore County Sheriff's Office, Mountain Home Police Department and Probation and Parole conducted a HIDTA operation focused on Interstate 84 in Ada, Canyon, and Elmore counties.

The operation resulted in a total of 131 contacts, 19 misdemeanor charges, 3 felony charges, 15 K9 deployments, 1 felony eluding, 1 pending federal charge for human smuggling, 1 jail escapee arrested, and 3 arrests related to a catalytic converter theft ring. The total amount of drugs seized was 88.5 grams marijuana, 46 DU of marijuana edibles, 1 DU of LSD, 1.4 grams of methamphetamine, 2 grams of marijuana wax, and 3 DU of cannabis oil.

• On May 10, 2022, an ISP trooper conducted a traffic stop in Kootenai County on a silver Chevrolet Malibu with Texas plates for failure to use turn signal. During the stop, the trooper observed paraphernalia in plain view. The driver of the vehicle admitted to using cocaine the day before. A search of the vehicle resulted in the seizure of cocaine, marijuana, THC wax, THC edibles, morphine, and hydrocodone.

While conducting a search of the vehicle, the Trooper located 195.61 grams of cocaine, 20.37 pounds of marijuana, 3.19 pounds of THC wax, 2.06 pounds of THC edibles, 3 dose units of morphine, and 4 dose units of hydrocodone.

• On June 8, 2022, an ISP trooper conducted a K9 sniff on a suspicious package for the United States Postal Inspector in Boise County.



• On June 13, 2022, an Idaho State Police trooper conducted a traffic stop in Bonneville County on a white Hyundai Santa Fe rental with California plates for window tint violation.

During the stop, the trooper smelled marijuana coming from the vehicle. The driver of the vehicle admitted to occupants in the vehicle smoking marijuana a few minutes before the stop. A search of the vehicle resulted in the seizure of fentanyl, methamphetamine, and a firearm. While conducting a search of the vehicle, the trooper located 10.2 grams of methamphetamine, 2,190 dose units of fentanyl and a .22 revolver. The subjects admitted to picking up the fentanyl in Arizona and were taking it to Minnesota to sell. Once they returned to Arizona they would be paid \$10,000 for trafficking the fentanyl.

• On June 20, 2022, an Idaho State Police trooper conducted a traffic stop in Power County on a tan Ford F150 with California plates for traveling under the speed limit and for failing to signal.

During the stop, the trooper smelled marijuana along with the driver admitting to having marijuana in the vehicle. A search of the vehicle resulted in multiple packages of marijuana located in bags in the bed of the truck. The trooper located 26.44 pounds of marijuana, 6.03 pounds of THC wax, 5 THC vape cartridges, 391.1 grams of marijuana edibles, and \$1,440 in cash.

LINN COUNTY INTERAGENCY NARCOTICS ENFORCEMENT

- The Linn County Interagency Narcotics Enforcement team (LINE) is still at half manpower with both Linn County spots vacant due to staffing issues. However, that has not stopped the influx of investigations for the team. LINE continues to focus on identifying, disrupting, and dismantling Drug Trafficking Organizations (DTO's). The primary focus as of late has been overdose investigations all fatal and some non-fatal when time allows. In quarter 2, Linn County has had 50 total known overdoses, 43 non-fatal and 7 fatal. Of the 50 overdoses, LINE has investigated or is investigating nine of them.
- On May 6, 2022, Albany PD and LINE responded to a fatal overdose. Evidence of drug use was recovered at the scene along with the victim's cell phone. Using the victims cell phone LINE was able to ID the level one source using victims mapping application and text messages. LINE communicated with the suspect via the victim's phone and arranged a controlled purchase. When the suspect arrived, she was arrested. A consent search of her residence was conducted, and an interview took place. The suspect was somewhat cooperative and willing to work level 2. She however changed her mind some days later.

LINE communicated with their Eugene DEA counterpart and the AUSA's office regarding the case. On June 29, 2022, the suspect was arrested by LINE and transported to Eugene where she was lodged and is being prosecuted federally.

ROGUE AREA DRUG ENFORCEMENT

- During the 2nd quarter, Rogue Area Drug Enforcement (RADE) detectives seized the following during investigations:
 - ½ pound of powdered fentanyl with the source of supply being Hondurans out of San Francisco, CA
 - 1303 M30 fentanyl pills
 - 2.8 pounds of methamphetamine
 - 25 firearms
 - \$17.816 dollars in drug proceeds
 - Assisted in seizing 44,819 marijuana plants and 9510 pounds of processed marijuana

RADE detectives worked with several agencies to seize the above narcotics and assets. The agencies are Drug Enforcement Administration (DEA) Medford, Medford Area Drug and Gang Enforcement (MADGE), Oregon State Police (OSP) SWR DES and Josephine Marijuana Enforcement Team (JMET).

MEDFORD AREA DRUG AND GANG ENFORCEMENT

♦ Medford Area Drug and Gang Enforcement (MADGE) has been actively working a case since the end of last year that has already resulted in the seizure of 12 pounds of methamphetamine as well as heroin, fentanyl, and cocaine. The suspect has been transporting large quantities of drugs to Jackson County from northern California.

In April 2022, MADGE detectives located the suspect in a vehicle in Medford, OR. After a K-9 alerted to the vehicle, a search warrant was granted and detectives seized 6 pounds of methamphetamine. The suspect was arrested and lodged on possession, manufacturing, and distribution of methamphetamine.





♦ MADGE has been investigating a subject for selling large quantities of methamphetamine in Jackson County. In April, 2022 MADGE made contact with the suspect during a traffic stop and a K-9 alerted to the vehicle.

MADGE continued

The suspect admitted to ownership of a plastic bag that contained a box of Wheat Thins. Inside the box of Wheat Thins was a zip lock bag containing 1.02 pounds of methamphetamine.

• In fall of 2021, MADGE opened an investigation into a suspect bringing methamphetamine to Medford from the Sacramento area. In May 2022, detectives located the suspect at a motel in Ashland, OR. A K-9 alerted to the vehicle and a telephonic search warrant was granted for the vehicle. Inside the vehicle detectives located 2.92 pounds of methamphetamine and \$13,143. The suspect had \$1,012 on his person. A total of \$14,155 was seized along with the methamphetamine.

Illegal Marijuana Enforcement Team - IMET

After a yearlong investigation, the Illegal Marijuana Enforcement Team (IMET) served three search warrants in Medford related to an illegal/black market marijuana shipping Drug Trafficking Organization (DTO). The warrant locations included two residences, one business, and a bank account.

The total amount seized was:

- \$1,207,870
- 14 firearms
- .90 pounds of Psilocybin
- 5.49 pounds of marijuana edibles
- 2.90 grams of Butane Honey Oil

This is an ongoing investigation. The U.S. attorney's office is prosecuting this case at the federal level.

MADGE /IMET continued...

• During the 2nd quarter IMET opened an investigation into an illegal marijuana grow site in Eagle Point, OR in Jackson County. A search warrant was granted for the property.

IMET seized: 835 illegal marijuana plants, 1,018.40 pounds of processed marijuana, and 15 firearms including an illegal short-barreled rifle with no federal tax stamp. This is an ongoing investigation. Jackson County Code Enforcement and Water Master are conducting independent investigations related to non-permitted structures, unsafe structures, and water theft.



• After a lengthy investigation, IMET executed a search warrant at a property in Central Point, OR in Jackson County.

This case was similar to many IMET has worked in recent years, wherein the homeowner leased his property to subjects who informed him they wanted to grow hemp, but were in fact, growing illegal marijuana.

IMET seized: 4,815 illegal marijuana plants and \$10,317.

This is an ongoing investigation. To date two subjects have been arrested and lodged on possession, manufacturing, and distribution of marijuana.

2nd Quarter Update ~

• The Multnomah County Sheriff's Office Dangerous Drug Team (MCSO DDT) continues to seize commercial quantities of fentanyl pills. A lot of dealers are only willing to sell "boats" indicating the surplus of fentanyl. MCSO DDT is also continuing to seize firearms in nearly every case. One of the guns seized in a recent case was linked to two recent homicides.

• A second MCSO DDT case featured a parolee who was selling methamphetamine by the pound.

A ruse was set to have the parolee report to his Parole Officer (P.O.) for an "early termination" from parole meeting. The suspect was taken into custody and a search warrant executed.

Seven guns (including a modified rifle with suppressor) and over 2 pounds of methamphetamine were seized. The suspect even brought a handgun to his P.O.'s office. The suspect is facing federal prosecution.

• During the 2nd quarter of 2022, MCSO DDT also assisted the US Marshals for a week-long mission focused on violent offenders across Multnomah County and adjoining counties. The mission proved successful by taking numerous guns and felons off the streets.

OREGON STATE POLICE DOMESTIC HIGHWAY ENFORCEMENT

• On May 9, 2022, troopers assigned to the Oregon State Police (OSP) - Portland Area Command stopped a 2003 Jaguar sedan for traffic violations on Interstate 5 northbound near milepost 290. During the traffic stop, the driver did not possess any form of identification and gave a fictitious name. The driver claimed to be 18 and had over an ounce of marijuana in his possession and in plain view. The driver was detained for Failure to Carry & Present and Giving False Information to a Police Officer. A consent search of the vehicle revealed 2,844 dosage units of suspected fentanyl and over \$4,000 in U.S. currency.

The driver was transported to the OSP Portland Area Command where troopers we able to confirm his identity. An inquiry through LEDS/NCIC revealed an outstanding warrant issued for the driver's arrest. The driver was lodged in Multnomah County Juvenile Detention Center on the warrant. Troopers were assisted during the investigation by members of the OSP Drug Enforcement Section-HIDTA Interdiction Team and Special Agents with the Drug Enforcement Administration (DEA)-Salem Resident Office.

• On May 13, 2022, an Oregon State Police trooper assigned to the Portland Area Command had a mere encounter with a male and female occupying a vehicle at the French Prairie Rest Area (adjacent to Interstate 5 southbound near milepost 281).

While talking with the occupants, the trooper observed a partially concealed handgun inside the vehicle next to where the male subject was seated. Both occupants stated they were under 21. The male was detained and the female was separated from the vehicle. An arm -span search of the vehicle revealed 2 additional handguns (which were later found to be reported stolen out of the Portland area), high capacity magazines, ammo, 34 grams of methamphetamine, \$4,541 in U.S. currency, digital scales and 129 dosage units of fake M-30 pills believed to contain fentanyl. The male was also found to have an outstanding warrant for his arrest. The male was interviewed by members of the OSP Drug Enforcement Section-HIDTA Interdiction Team and later lodged in jail.

• On June 1, 2022, Oregon State Police troopers assigned to the Baker City worksite contacted a vehicle believed to be involved in a crash at the intersection of State Route 7 and Interstate 84 in Baker City. During the investigation it was learned no crash occurred, however, the operator of the vehicle failed to provide a driver's license and after being detained for Failure to Carry and Present License it was determined the subject had provided false information. Once the subject's identity was known, troopers were advised of multiple outstanding out-of-state warrants for his arrest.

The Baker City Police Department assisted in the investigation and provided a drug detection canine. The K9 alerted to the presence of controlled substances and the vehicle was towed from the scene pending a search warrant. The suspect was arrested for the outstanding warrants and lodged at the Baker County Jail. A subsequent court authorized search warrant resulted in the seizure of the following items from the vehicle:

- Methamphetamine 1,302.37g
- Fentanyl powder 40.2g
- Fentanyl pills –15,962 dosage units
- Marijuana 2.02lbs
- Buprenorphine/Naloxone 21 dosage units
- Cocaine 21.8g
- Unknown substance 9.3g

- 9mm pistol
- .223 Assault Rifle (without a serial number)
- .17 rifle
- .38 Special
- .2283 pistol
- .45 pistol
- Ammunition and magazines

Troopers were assisted during the investigation by members of the OSP-HIDTA Interdiction Team and the Baker City Police Department.

Drugs and firearms seized in Baker City







• On June 7, 2022, as part of an ongoing joint investigation, members of the OSP Drug Enforcement Section (DES)-HIDTA Interdiction Team and the USPS-Postal Inspection Service received information that a suspicious parcel was shipped from Maywood, California and was inbound to the residence of a known local drug trafficker in Nyssa, Oregon. On June 8, 2002, the parcel arrived at the USPS-Boise facility. A controlled K9 sniff of the parcel was conducted utilizing an Idaho State Police (ISP) drug detection K9. After the ISP K9 positively alerted to

the parcel, investigators applied for a federal search warrant for the parcel. Once the search warrant was signed, the parcel was opened, revealing approximately 6 pounds of suspected methamphetamine. On June 9, 2022, investigators applied for an anticipatory federal search warrant for the suspect's residence in Nyssa, as well as a warrant for his arrest for violating the terms of his federal parole. A controlled delivery was planned for the following day. Once the parcel was accepted, the search warrant for the residence would be served.

Investigators also learned the suspect's girlfriend, who recently had a baby, also occupied the residence. Additionally, she also had an outstanding felony warrant issued for her arrest. On June 10, 2022, members of the United States Postal Service-Postal Inspection Service, Bureau of Alcohol ,Tobacco, Firearms and Explosives, OSP-HIT, OSP-SWAT and the OSP-Ontario Area Command, as well as the Nyssa Police Department, successfully conducted the controlled delivery and then attempted to serve the search warrant on the residence. Once the parcel was delivered to the front porch of the residence, a female, later identified as the suspect's girlfriend, came outside and retrieved the parcel.

When SWAT members attempted to serve the warrant, the female barricaded herself inside and would not come out. It was also discovered the female's infant child was inside the residence. Eventually, SWAT members convinced the female to surrender with her child. The female was taken into custody without further incident. DHS responded to the area and took the child into protective custody.

When investigators debriefed the female, it was discovered that another female, who was known to local law enforcement, was still inside the residence. That female suspect also had an outstanding felony warrant for her arrest. After an extended period of time and extensive efforts by SWAT members, the second female agreed to surrender. She was taken into custody without further incident. Prior to her arrest she was believed to have consumed several pills containing fentanyl and began exhibiting signs and symptoms of drug overdose. Investigators had staged medical personnel prior to the operation and they responded to assist. The second female was transported to a local hospital for advanced care. She fully recovered and was lodged in the Malheur County Jail.

While searching the residence, investigators found the female suspects attempted to destroy the contents of the parcel, but were unsuccessful. Investigators also recovered an additional one-half pound of suspected methamphetamine, which was in the house prior to the operation. At this time, the male suspect who was the focus of the investigation has not been located, but investigators are actively searching for him.

• On May 25, 2022, an OSP trooper assigned to the drug detection K9 Program-Bend stopped a 2021 Chevy Malibu for a speeding violation on Highway 97 northbound near milepost 277. During the traffic contact, the trooper observed numerous signs of criminal activity. Consent to search the vehicle was requested and granted by the driver. During the consent search, troopers located over 32 pounds of methamphetamine and 2.3 pounds of cocaine in the trunk of the vehicle. On the front passenger seat, troopers located a loaded Glock 21 pistol concealed in a backpack.

On June 29, 2022, an OSP trooper assigned to the Drug Detection K9 Program-Salem stopped a 2019 Hyundai SUV for traffic violations near Interstate 5 and Mission Street, Salem, Oregon. During the traffic stop, the trooper observed signs of criminal activity. The occupants admitted to possessing a criminal amount of marijuana and consented to allow the trooper to recover the marijuana from the vehicle. During a search of the vehicle, the trooper located 16.9 pounds of marijuana concealed in a suitcase and \$130,812 in U.S. currency concealed in a backpack. The driver and passenger were transported to the OSP Salem Area Command where they were interviewed and later released. Investigators determined the U.S. currency was proceeds obtained through criminal activity.

Troopers were assisted during the investigation by detectives from the OSP Drug Enforcement Section-HIDTA Interdiction Team and Special Agents from the DEA Salem Resident Office.

• On June 15, 2022, an OSP trooper assigned to the Klamath Falls Area Command contacted the occupants of a 2019 Land Rover SUV at the Midland rest area, along Highway 97 northbound near milepost 283. During the contact, the trooper developed probable cause to believe the occupants were involved in criminal activity. The trooper applied for a search warrant for the vehicle, which was granted. A subsequent search of the vehicle revealed 13.9 pounds of methamphetamine and 5 pounds of suspected fentanyl pills located in bags in the cargo area of the vehicle.

Troopers were assisted during the investigation by members of the OSP Drug Enforcement Section-HIDTA Interdiction Team. The suspects were transported to the Klamath County Jail where they were lodged.

U.S. MARSHALS SERVICE FUGITIVE TASK FORCE

• On April 18, 2022, a Washington State fugitive with two outstanding felony warrants rammed multiple police vehicles and nearly struck a nearby officer while attempting to escape arrest in southeast Portland. Roman Culver, 23, of Covington, Washington, was arrested by U.S. Marshals Service Pacific Northwest Violent Offenders Task Force (PNVOTF) deputies and officers from Portland, OR and Vancouver, WA. Culver was wanted by authorities in King County, Washington for first degree robbery with a firearm and by the Washington Department of Corrections for the charge of escape. In addition to the warrants, there is probable cause to arrest Culver in two Washington State jurisdictions for a drive by shooting and an Assault I for an alleged carjacking. Culver is also a person of interest in a homicide.

While conducting the fugitive investigation, PNVOTF members located Culver in a vehicle in southeast Portland. The parked vehicle also contained three other people, one male and two females. When task force members attempted to block Culver's vehicle in a parking spot, Culver placed his vehicle in reverse and rammed the police vehicles. Investigators commanded Culver to stop, but he continued to accelerate.

As Culver attempted to maneuver his vehicle to escape, a nearby officer found himself between the vehicles and fired a single, defensive shot striking Culver in the neck. After the shot, Culver stopped his vehicle. Nearby officers detained all four individuals and rendered emergency medical aid to Culver and his male passenger until medical personnel arrived on scene. A handgun was recovered from inside the vehicle. Culver, who later admitted to knowing police were trying to arrest him, was transported to a nearby hospital for evaluation.

• On May 13, 2022, Andrew Cain Kristovich, 38, of Edmond, WA was located in the Northern Nevada area and taken into custody by Deputy U.S. Marshals with the assistance of Carson City and Douglas County Sheriff's Special Weapons and Tactics (SWAT) teams.

On April 25, 2022, while being housed at the Federal Correctional Institution - Sheridan, OR, Kristovich was able to hide in bushes and crawl through a prison fence, where he was picked up by his ex-girlfriend. The Bureau of Prisoners notified the United States Marshals Service (USMS) for assistance in locating the fugitive. Shortly after the escape, it is alleged Kristovich assaulted his ex-girlfriend and fled in her vehicle. This incident is being investigated by Clark County Sheriff's Office (Washington) and probable cause was established to arrest Kristovich for Rape in the Second Degree, Assault in the Second Degree-DV Strangulation, Robbery in the Second Degree, Unlawful Imprisonment and Auto Theft. Subsequently, Clark County Superior Court issued a no bail warrant for the above listed charges.

PNVOTF started a fugitive investigation as to the whereabouts of fugitive Andrew Kristovich. Kristovich was believed to be heading towards family in the Snohomish County area and two days after the escape, Edmonds police found the stolen car linked to Kristovich in a Burlington Coat Factory parking lot. Information was eventually developed that Kristovich fled south to Carson City, Nevada and that information was shared with the USMS District of Nevada, Reno office for assistance.

The Northern Nevada Fugitive Task Force developed a possible address and spent 48 hours on surveillance to confirm the location of Kristovich. With the assistance of Carson City and Douglas County Sheriff's Special Weapons and Tactics team, Kristovich was taken into custody on the property where he was staying in a tent. Located in the tent was an AR style rifle with five magazines. The United States Attorney's Office for the District of Nevada will review the case for possible federal charges of Felon in Possession.

USMS continued...

In June 2022, the United States Marshals Service, Pacific Northwest Violent Offender Task Force in coordination with the Multnomah County Sheriff's Office (MCSO), Multnomah County's Department of Community Justice (Parole and Probation), Gresham Police Department, Portland Police Bureau, and Bureau of Alcohol, Tobacco, and Firearms (ATF) conducted Operation Safer Multnomah, a U.S. Marshals-led initiative that targeted violent fugitives, focused efforts to reduce street level criminal activity, & identify and arrest criminal suspects involved in recent shootings. As a result, 24 arrests were made during the five-day operation from June 7-11, 2022. This operation was a massive undertaking, completed with the help of multiple law enforcement agencies and personnel assisting with investigations and arrests.

The individuals who were targeted and arrested were wanted for serious violent charges including murder, attempted murder, armed robbery, and assaults. Law enforcement personnel combed through hundreds of local, state, and federal warrants to search for the most dangerous offenders in the Multnomah County area. Over 30 law enforcement members assisted in this operation. This law enforcement partnership, with full support of Multnomah County Sheriff Mike Reese and Acting U.S. Marshal for Oregon Pete Cajigal, focused on reducing community violence by targeting individuals involved in criminal activity that has directly led to the increase in violent crime in the county.

Operational Stats:

- 24 fugitives arrested: 3 wanted for attempt murder by shooting, 1 pending a federal drug overdose death, 3 pending federal prosecution for possession of firearms and narcotics
- 21 firearms: 9 reported stolen, 3 ghost guns, 1 silencer seized (homemade)
- 3 pounds of methamphetamine
- 19 grams of heroin
- 449 fentanyl pills

Notable Arrests:

Jimmy Pearce, age 35, was wanted by the Washington County Sheriff's Office as a suspect in a 2017 homicide that occurred at the Xpose Club, located at 10270 SW Canyon Road in Beaverton, OR. He was located near SE Bush Street and SE 112 Avenue in Portland and was arrested without incident. Warrants include Murder in the Second Degree, Unlawful Use of a Weapon, Felon in Possession of a Firearm.

Andrey Mazur, age 32, was wanted for more than 36 armed robberies throughout the Portland and Vancouver, Washington metro area. With the assistance of Portland Police Special Emergency Response Team, Mr. Mazur was safely taken into custody after an hours-long standoff. During the standoff, Mr. Mazur cut his hair to change his appearance. A handgun recovered in the lawn outside of the Jantzen Beach residence is alleged to have been thrown there by Mazur. Mazur is a convicted felon.

Alexander Barber, age 27, was wanted for federal charges stemming from theft of more than 35 firearms from a licensed dealer and felon in possession of a firearm. Mr. Barber was arrested after being located hiding in the attic of a Portland residence. During the operation, law enforcement was able to locate and recover eight of the stolen firearms in this case through search warrants.

WESTSIDE INTERAGENCY NARCOTICS

• In the 2nd quarter of 2022, a Drug Trafficking Organization (DTO) was identified by the Westside Interagency Narcotics (WIN) team during an overdose investigation. WIN partnered with the Drug Enforcement Administration (DEA) D-51 task force on a T-III investigation targeting the Source of Supply & Leader (Operation Backcountry Sundae). Intercepts began on April 4, 2022.

Through intercepts and phone pings, WIN and DEA were able to intercept several load cars traveling from CA to Portland, OR. Search warrants on residences were also conducted through the course of the investigation. The total drugs seized during the T-III investigation were: methamphetamine 56,119.3g; fentanyl 449.7g; cocaine 654.8g; heroin 2,138.66g.

The three subjects have been indicted and arrested, with more indictments pending.







OVERDOSE RESPONSE STRATEGY

The Oregon Overdose Response Strategy team would like to offer a free training to HIDTA partners and other uniformed first responders. The training, *Harm Reduction Myth-busters: What can law enforcement learn from working with harm reduction?* was developed specifically for law enforcement to gain a better understanding of harm reduction services. This training will provide an overview of harm reduction, how stigma contributes to problematic substance use, an overview of substance use disorder, and how law enforcement and harm reduction can find ways to work together. By the end of the training, participants will:

- Have a basic understanding of harm reduction
- Know what harm reduction looks like throughout Oregon
- Be able to identify supplies distributed by harm reduction

- Have a basic understanding of treatment options
- Be able to dispel myths about harm reduction

In addition, participants in the training will be given the opportunity to address concerns they may have about harm reduction and discuss options for referrals to other services.
