Director's Message

The Oregon-Idaho HIDTA Program and the Washington-Baltimore HIDTA's Overdose Mapping Application Program (ODMAP) has partnered with the Clackamas County Fire District on an Automated Program Interface (API) between the Fire District's records management system, First Watch, and ODMAP. An API is a popular method for stakeholder agencies to contribute data without creating additional (manual) reporting or processes. The API allows for near real time de-identified overdose response data integration by connecting with the Clackamas County Fire District's First Watch system to ODMAP. The API allows for the direct, automated integration of the two systems as well as enhanced, multi-agency and disciplinary information sharing. In a little over a month, the API in Clackamas County has resulted in over 70 data transfers. The near real-time data derived from ODMAP and other systems in Clackamas County will be used to enhance overdose response strategies in the county.

CLACKAMAS COUNTY INTERAGENCY TASK FORCE

A San Jose, California man is facing federal drug trafficking charges after he arranged the sale of approximately 80,000 counterfeit oxycodone pills containing fentanyl and 66 pounds of methamphetamine. According to a press release from the United States Attorney's Office District of Oregon dated May 5, 2023, Oscar Manuel Rosas Gaona, 20, has been charged by criminal complaint with conspiring to possess and possessing with intent to distribute fentanyl and methamphetamine. According to court documents, in April 2023, special agents from Homeland Security Investigations (HSI) arranged to purchase 10,000 counterfeit oxycodone pills containing fentanyl for 70 cents per pill. On April 14, 2023, the agents, working in partnership with the Clackamas County Interagency Task Force (CCITF), completed the arranged purchase with Rosas.

As the investigation continued, a second purchase from Rosas was organized and, on April 27, 2023, agents obtained an additional 70,000 fentanyl pills. The next day, on April 28, 2023, Rosas began arranging the delivery and sale of 65 pounds of methamphetamine. By May 4, 2023, the methamphetamine had arrived in Oregon and was seized by law enforcement. Rosas was taken into custody the same day.

A Clackamas County, Oregon woman is facing federal drug charges for using social media to advertise, sell, and distribute illegal drugs to minors in and around Portland. According to a press release from the United States Attorney's Office District of Oregon dated June 15, 2023 Averi Rose Dickinson, 19, a resident of Damascus, Oregon, has been charged by criminal complaint with conspiring to distribute and distributing controlled substances and possessing a firearm in furtherance of a drug trafficking crime. According to court documents, in January 2023, the FBI began investigating Dickinson after learning she ran a drug distribution service called "Kiki's Delivery Service"

that advertised and took orders for illegal narcotics on various social media applications including Instagram, Snapchat, and Telegram.

Investigators soon discovered that Dickinson had been operating the service for up to three years, taking and fulfilling orders for cocaine, LSD, MDMA, ketamine, marijuana, and various forms of pills, both real and fake. Investigators also identified Dickinson as a source of supply within a larger drug distribution chain responsible for several juvenile drug overdoses. On June 14, 2023, investigators executed federal warrants on Dickinson's Damascus residence and vehicle. They located and seized quantities of cocaine, ketamine, marijuana, and counterfeit Xanax bars; \$3,000 in cash; a Glock 9mm handgun with extended magazine; an AR-style assault rifle; and a bullet proof vest. Dickinson told investigators she believed approximately 50% of her drug distribution clients were minors and that she used several minors as runners to deliver drugs.







CENTRAL OREGON DRUG ENFORCEMENT

• On June 12, 2023, a Bend man was indicted by the Deschutes County Grand Jury on several controlled substance and a possession of silencer charges. This was the result of a months-long investigation by the Central Oregon Drug Enforcement (CODE) team and was concluded when drug agents executed a search warrant at his home on the 17000 block of Kasserman Dr in the Three Rivers area of Bend.

On April 5, 2023, the CODE team, in collaboration with the Deschutes County Sheriff's Office, concluded a long-term investigation and surveillance operation with the arrest of Justin Thomas Polit, age 45, of Bend, Oregon. In early 2023, drug agents identified Justin Polit as a cocaine trafficker in central Oregon. The initial investigation alleges Mr. Polit has been importing large quantities of cocaine into central Oregon, where he distributes throughout the Bend area. After a surveillance operation, CODE detectives, with the assistance of Deschutes County Sheriff's Office deputies, stopped Mr. Polit while he was driving a 2005 Chevrolet Silverado on Lazy River Dr, near South Century.

Because of his extensive criminal history, Lazy River Dr was closed while patrol deputies and drug agents conducted a high-risk traffic stop. Based on the investigation, CODE detectives applied for and obtained a search warrant for Mr. Polit's truck and home. A subsequent search of Polit's home located a substantial quantity of cocaine, currency, firearms, firearm suppressors, silencers and a 3D printing system used to manufacture the illegal firearm parts.

In March of 2022 and unrelated to this case, Mr. Polit petitioned the Deschutes County Circuit Court to allow him to purchase and possess firearms under Oregon Revised Statute 166.274. Although the courts restored his gun rights, he is not permitted to manufacture or possess firearm silencers.

DOUGLAS INTERAGENCY NARCOTICS TEAM

• On April 6, 2023, detectives with the Douglas Interagency Narcotics Team (DINT) arrested two Honduran men. DINT had been investigating this organization for some time and developed information indicating they are involved with large scale drug trafficking crimes. Detectives contacted the individuals as they were sitting in their vehicle in the parking lot of a business in the 700 block of NW Garden Valley Blvd in Roseburg, OR at approximately 2:45 AM. The individuals had just arrived in the area from California. Both individuals were detained, pending application for a search warrant for their vehicle. Detectives obtained the search warrant and upon searching the vehicle found a huge amount of both methamphetamine and fentanyl, including a large amount of suspected carfentanil.

In the suspects' vehicle, detectives located the following;

- Approximately 1,614 grams (3.5 lbs.) of suspected methamphetamine
- Approximately 2,000 grams (2 kilos or 4.4 lbs.) of suspected fentanyl
- Approximately 1,000 grams (1 kilo or 2.2 lbs.) of suspected carfentanil
- Assorted drug paraphernalia

32 year old Jorge Alvarenga, and 26 year old Daniel Mendoza-Archaga were both lodged in the Douglas County jail on the following charges:

- Unlawful Possession, Manufacture, and Delivery of Methamphetamine
- Unlawful Possession, Manufacture, and Delivery of a Controlled Substance Schedule II
- On May 12, 2023, DINT detectives, working in conjunction with deputies from the Douglas County Sheriff's Office, conducted a drug investigation which resulted in the arrest of 51 year old Randall Slay of Myrtle Creek, OR.

Detectives had been investigating suspected drug activity and generated reason to believe Slay was in possession of a large amount of methamphetamine. Deputies with the Douglas County Sheriff's Office conducted a traffic stop on Slay in his vehicle near the intersection of S. Pacific Hwy and Gael Lane. Drug detection K-9 "Trapper" was applied to Slay's vehicle and he alerted to the odor of narcotics coming from inside. As he was being ordered from the vehicle, Slay instead chose to flee. A pursuit began as Slay drove away in his vehicle, northbound on S. Pacific Hwy toward Myrtle Creek. As deputies gave chase they could see Slay throwing items from the vehicle. Deputies believed Slay to be throwing drugs from the vehicle as he was being chased. Slay threw several items from his vehicle, all of which were collected by DINT detectives who were in the area.

Slay yielded to police in the 100 block of N. Pacific Hwy in Myrtle Creek and he was immediately taken into custody. Detectives were able to recover much of what Slay had thrown from the vehicle, which included approximately 106 grams of suspected methamphetamine on S. Pacific Hwy near Susan Street, and approximately 14 grams of suspected methamphetamine on S. Pacific Hwy near Crest Street. Upon detaining Slay, detectives found remnants of suspected methamphetamine on his shirt, as well as another 18 grams of suspected methamphetamine in his pocket. A search of Slay's vehicle revealed even more, another 6.4 grams of suspected methamphetamine.

• On May 30, 2023, 41 year old Alma Adriana Fuentes of Live Oak, California, was contacted during the course of a traffic stop on Interstate 5 near Sutherlin, OR. During the traffic stop, an Oregon State Police canine was applied to Fuentes' vehicle and positively alerted to the presence of controlled substances.

A search of the vehicle resulted in the seizure of a kilogram (2.2 pounds) of suspected carfentanil. Carfentanil is a synthetic opioid which is 10,000 times more potent than morphine and 100 times more potent than fentanyl.

Suspect interviews indicated the carfentanil was destined for Douglas County, but intercepted before it could reach it's final destination. Fuentes was arrested by DINT detectives.

FBI TREASURE VALLEY METRO VIOLENT CRIME TASK FORCE

• On April 4, 2023, the Treasure Valley Metro Violent Crime Task Force, a multi-agency gang task force headed by the FBI in Boise, ID, executed a search warrant in Nampa, Idaho, in conjunction with an ongoing investigation. During the search, the Task Force seized approximately 13.5 pounds of methamphetamine, approximately 19,900 fentanyl pills, and three firearms. Rigoverto Rivera Hernandez, a known Sureno gang member, was arrested on scene, and the case will be submitted to the United States Attorney's Office for the District of Idaho for prosecution consideration.

The Metro Task Force was formed in 2005 amidst a consistent upsurge of gang violence in the Treasure Valley. Metro is funded and supervised by the FBI, with personnel assigned to the Task Force from city, county, state, and other federal law enforcement agencies. Metro's mission is to conduct long-term, complex investigations of gangs and other criminal enterprises. The majority of Metro's cases are adjudicated in federal court.

To date, Metro has submitted cases federally resulting in the indictment of over 530 individuals. More than 100 additional individuals have been indicted in State court on various criminal charges. Metro has seized countless amounts of drugs over the past seventeen years and has seized over 600 firearms possessed illegally by gang members and other criminals. In the past month alone, Metro has seized 15 firearms, over 15.5 pounds of methamphetamine, and over 20,000 fentanyl pills.


HIDTA INTERDICTION TASKFORCE

• During the 2nd quarter of 2023, members of the HIDTA Interdiction Taskforce (HIT) were paged on 75 overdose deaths. The overwhelming majority of those deaths are related to fentanyl.

HIT also responded to 4 overdose incidents involving children under the age of 3 years old. Luckily not all of those overdoses were fatal. HIT is working multiple overdose investigations from quarter 2.

• During the 2nd quarter of 2023, HIT investigators were working criminal narcotics interdiction with a focus on couriers that were using commercial bus lines to transport narcotics into the Portland Metropolitan area. With the use of consensual encounters and a narcotics K9, HIT investigators seized two passenger bags containing methamphetamine.

A total of twenty four (24) pounds of methamphetamine was seized. This interdiction initiated a larger investigation into the group's network in the Portland Metropolitan area.









Members of the HIDTA Interdiction Taskforce (HIT) conducted follow up on an overdose death involving fentanyl that occurred on April 29, 2023. HIT identified Evan Coffman (DOB 10/23/1981) as the level 1 supplier to the deceased. HIT conducted surveillance and located Coffman and his apartment in the City of Portland.

On May 9, 2023, HIT investigators arrested Coffman in front of his apartment. A search warrant was written for the residence. At the residence officers found a kilo press, \$8,120 cash, 623 grams of methamphetamine, 899 grams of heroin, 25,096 blue M30's and 1,802 grams of powder fentanyl.

IDAHO STATE POLICE - DOMESTIC HIGHWAY ENFORCEMENT

• On June 22-23, 2023 the Idaho State Police Domestic Highway Enforcement team in conjunction with Ada County, Nampa Police Department, Payette Police, and Probation and Parole conducted a HIDTA operation focusing on I-84 in Ada, Canyon, and Payette Counties.

The operation resulted in a total of 95 contacts, 24 misdemeanor drug charges, 4 felony drug charges, 1 eluding police charge, 1 felony destruction of evidence charge, 2 resist and obstruct charges, and 2 false information to officer charges.

• On April 14, 2023, an Idaho State Police (ISP) Trooper conducted a traffic stop in Twin Falls County on a gray Dodge Journey with Arizona plates for following too close.

During the stop, the trooper observed signs of criminal activity. The driver of the vehicle admitted to having pills inside the vehicle that he used for pain. While conducting the search of the vehicle, the trooper located 108 dose units of fentanyl, .6 grams of methamphetamine, a Ruger revolver and \$1,060 in US currency.

• On April 20, 2023, an ISP Trooper responded to a suspicious subject in a parking lot in Nez Perce County in a rented silver Dodge Ram 1500 with Washington plates.

During the encounter, the trooper observed marijuana in plain view inside the vehicle, and the occupants admitted having drugs. A witness in the parking lot later informed troopers that occupants attempted to sell him drugs. While conducting a search of the vehicle, the trooper located 486 dose units of fentanyl, 201.9 grams of methamphetamine, and 20.2 grams of marijuana.

• On May 18, 2023, an ISP Trooper conducted a traffic stop in Minidoka County on a maroon Dodge Ram 2500 towing a camp trailer with Montana plates for failing to maintain lane and suspicion of shoplifting.

During the stop, the trooper confirmed a felony warrant for the occupant and located numerous stolen items within the camper. While conducting a search of the vehicle, the trooper located 13.7 grams of fentanyl pills, 500 blue pills containing bromazolam, and 500 yellow pills containing Xylazine, a fixed blade knife and over \$40,000 in stolen merchandise.

• On June 6, 2023, an ISP Trooper conducted a traffic stop in Bannock County on a rented black Dodge Charger with Minnesota plates for turn signal violation

During the stop, the trooper observed signs of criminal activity. A K9 was requested and performed an open-air sniff and received a positive alert. While conducting a search of the vehicle, the trooper located 3 pounds of methamphetamine locked in a safe in the trunk

MEDFORD AREA DRUG AND GANG ENFORCEMENT

2nd Quarter Update ~

The Medford Area Drug and Gang Enforcement team (MADGE) opened an investigation into a suspect believed to be bringing large quantities of fentanyl pills from Arizona to Medford. They made contact with the suspect at a hotel in Ashland, OR. The suspect attempted to flee in his car and in doing so rammed two detective cars and narrowly missed injuring a MADGE officer. The suspect damaged his car and MADGE was able to move in. The suspect resisted arrest but MADGE was able to take him into custody.

The suspect admitted to having more than 4,000 fentanyl pills in his vehicle. He admitted to transporting the pills from Arizona with the intent to sell them in Jackson County for \$5,000. He was also in possession of a stolen firearm. The suspect was lodged at the jail on possession, manufacturing, and distribution of schedule II controlled substance, elude in a vehicle, resisting arrest, recklessly endangering, hit and run property x 2, and attempted assault 2.

• MADGE had been investigating a drug trafficking organization (DTO) operating out of Mexico. MADGE conducted a traffic stop on I-5 and K-9 Max alerted to the vehicle. The female driver gave consent to search the vehicle and MADGE seized 9.97 pounds of methamphetamine.

The driver admitted she was going to receive \$2,500 for delivering the drugs to Medford. She was cited and released and the case remains under investigation.

• MADGE made contact with a suspect they had been investigating for selling fentanyl in the Medford area. K-9 Max alerted to the vehicle the suspect was driving. The suspect consented to a search of his vehicle and detectives located one pound of fentanyl and a quarter pound of methamphetamine.

The suspect admitted to traveling to the San Francisco Bay Area and purchasing fentanyl and methamphetamine to sell in Jackson County.

• MADGE served a search warrant on a suspect's vehicle and his residence in Talent, OR. By the end of the search warrant MADGE seized 3.67 pounds of methamphetamine.

MADGE is continuing their investigation on this case.

Illegal Marijuana Enforcement Team - IMET

- During June 2023, the Illegal Marijuana Enforcement Team (IMET) served a search warrant outside of Rogue River, OR. IMET destroyed 800 illegal marijuana plants after obtaining a destruction order. This case remains under investigation.
- During the 2nd quarter of 2023, IMET recently executed a search warrant outside of Ashland, OR where they located 22 hoop-style greenhouses. A total of 8,616 illegal marijuana plants were destroyed per court order. The landowner was fined \$13,000 by Jackson County Code Enforcement. The Water Master also cited the landowner for water violations. This case remains under investigation.

- After a lengthy investigation, IMET served a search warrant on two tax lots outside of Rogue River, OR. The investigation took place both on the ground and during a flyover of the property. By the end of the search warrant 2,250 illegal marijuana plants were destroyed per court order. Jackson County Code Enforcement issued \$15,000 in fines and the Water Master issued a citation for illegal use of surface water without valid water rights. This case remains under investigation.
- IMET executed a search warrant at a property outside of Jacksonville, OR. Upon arriving at the illegal marijuana grow site, one subject immediately ran from law enforcement but was found hiding in blackberry bushes and taken into custody. He was lodged at the jail on charges of possession, manufacturing, and distribution of marijuana and interfering with a peace officer. Charges are pending at the district attorney's office for another subject. Other subjects were questioned and released from the scene.

A total of 1,163 illegal marijuana plants were destroyed on site per a court order.

LINN INTERAGENCY NARCOTICS ENFORCEMENT

• In May of 2023, the Linn Interagency Narcotics Enforcement (LINE) team executed two simultaneous search warrants with the assistance of the Linn Interagency SWAT team. These search warrants were the result of a month's long investigation into a familiar suspect whom LINE, local law enforcement, and Linn SWAT had served several search warrants on in the past. The suspect's residence is in town but off grid, heavily fortified and surveilled making it very difficult to approach with stealth and even more difficult to enter in a timely manner. These are the reasons why in the past not much evidence had been recovered.

On this occasion SWAT served the warrant on the main suspects residence while LINE served the warrant on a suspected stash house. SWAT was successful in making a speedy entry onto the property and conducted a port to deny access of the main suspect to his master bath. The suspect was able to destroy some evidence in his toilet but not all. In total, LINE seized 10,005.6 grams of methamphetamine, 998.2 grams of heroin, 1.3 grams of cocaine, 756.8 grams of powder fentanyl, 3,624 fentanyl pills, and \$10,430 in cash.

MULTNOMAH CO. SHERIFF'S OFFICE DANGEROUS DRUG TEAM

• Diligent work by the Multnomah County Sheriff's Office Dangerous Drug Team (MCSO DDT) resulted in the largest illegal fentanyl seizure in MCSO's history. On July 25, 2023, DDT deputies were conducting surveillance of a wanted subject in the area of the 2000 block of SW Main Street in Portland, OR. When the subject was arrested on an outstanding warrant, a search warrant was obtained and deputies discovered gallon size plastic bags packed with fentanyl pills and fentanyl powder as well as scales, a manual operated pill press, a commercial grade pill press, \$5,000 in cash and a handgun (later determined to be stolen).







The bags contained approximately 58,000 individual fentanyl pills and 16 pounds of fentanyl powder. Ten of the 16 pounds of powder was ready to be pressed into pills. In total, it's estimated DDT deputies prevented approximately 138,000 pills from hitting Portland area streets. The combined estimated street value of the fentanyl pills and powder is between \$320,000-\$400,000.

OREGON STATE POLICE DOMESTIC HIGHWAY ENFORCEMENT

On June 1, 2023, an Oregon State Police (OSP) Trooper and K9 Nero stopped a vehicle on I-5 near MP 218 in Linn County for a traffic violation. While taking enforcement action the trooper developed suspicion the occupants were involved in criminal activity. The trooper requested and received consent to search the vehicle from both occupants. During the search he recovered 2 large packages of controlled substances which were later found to be 5 pounds of powdered fentanyl.




One of the subjects was found to have a warrant out of California and was arrested and lodged without incident.

On June 10. 2023 an OSP Trooper and his K9 Nero stopped a vehicle on I-5 near MP 217 in Linn County for a traffic violation. While taking enforcement action the trooper developed suspicion the occupants were involved in criminal activity. K9 Nero sniffed the exterior of the vehicle and alerted. Nero's handler searched the vehicle and found 21.4 lbs. of methamphetamine.

WESTSIDE INTERAGENCY NARCOTICS

- In April of 2023, the Westside Interagency Narcotics (WIN) team served a search warrant and seized 21 pounds of methamphetamine, 675 grams of heroin, 4 handguns, and 1 assault rifle.
- In April 2023, WIN assisted Beaverton PD Patrol with a drug investigation. The investigation resulted in 61 grams of fentanyl powder, 1 gram of fentanyl pills, 1 gram of meth, and one handgun seized.




